- The most economically advantageous or lowest evaluated quotation shall be awarded the tender.
- Preference will be given to the bidder with the shortest possible delivery time
- A bid validity period of **thirty (30) days** is required, bidders must state validity period.
- Delivery period must not be more than four weeks. Bidders must state the delivery period.
- **Bidders must attach a copy of current and valid Tax Clearance Certificate in the prescribed Form ITF 263 for local bidders and equivalency for foreign bidders.**
- Powertel payment terms for this specific transaction will be within 30 days after delivery and acceptance testing. Bidders are required to confirm in writing acceptance of this condition.
- Payments will be made into a local Zimbabwean Real Time Gross Settlement (RTGS) FCA Account.
- **The price quoted by Bidders must be all-inclusive showing the cost and Value Added Tax (VAT) separately.**
- Bidders are free to attend the tender opening on the closing date and time.

- **Bids must be quoted in RTGS dollars.**
- **Bids quoted in United State dollars (USD) will be rejected.**

- **Bidders must provide proof of current registration with the Procurement Regulatory Authority of Zimbabwe (PRAZ) in the appropriate category. Bidders must provide an extract from the Government Gazette as proof of registration or letter from PRAZ.**
- Powertel reserves the right to accept or reject any or all Bids at its discretion, without assigning any reason whatsoever. Powertel is not bound to accept the lowest offer or bid and reserves the right to cancel or annul the tender at any time before awarding of the tender or signature of the contract.
