- The most economically advantageous or lowest evaluated quotation to specification shall be awarded the tender.
- Preference will be given to the bidder with the shortest possible delivery time
- A bid validity period of 30days is required, bidders must state validity period.
- Delivery period must not be more than 14 days, bidders to state delivery period.
- **Bidders must attach a copy of current tax clearance certificate.**
- Payment is to be made after delivery and acceptance testing, bidders to confirm in writing acceptance of this condition.
- **Bidders must provide proof of current registration with the Procurement Regulatory Authority of Zimbabwe in the appropriate category.**
- **Price should be in USD and payable at the prevailing interbank rate on the date of payment**
- **The price must be all inclusive showing cost and VAT shown separately.**
